How can I access Kaiser Permanente Hearing Center services?

You must have your hearing tested by a Kaiser Permanente audiologist who will produce an audiogram for each ear. If a hearing aid is deemed necessary, you can contact your local Hearing Center to schedule an appointment for a hearing aid consultation.

Do I need to be a Kaiser Permanente member to use Hearing Center services?

Nonmembers and members who do not have hearing aid benefits can still purchase competitively priced hearing aids through a Kaiser Permanente Hearing Center. However, you must have a current hearing test and medical clearance for a hearing aid prior to purchasing a hearing aid. Kaiser Permanente members can have a Kaiser Permanente audiologist conduct a hearing test, and nonmembers should have their hearing tested by a licensed audiologist through their health care provider.

How can I find out if I have a hearing aid benefit?
